

Gifts and Donations of Land

Explore partnership options with your local land trust through:

Donations of Real Estate

Donations to a land trust of ecologically important land can net significantly increased charitable tax credits for the donor through the Ecological Gifts Program, Environment Canada. (0% capital gains.) Land must be assessed and certified for its environmental values. Land trusts are authorized Ecological Gift recipients and they will monitor and steward the land in perpetuity.

Gifts of land that do not meet Ecological Gift criteria will also be eligible for charitable tax credits, at the standard rates, but subject to capital gains.

Conservation Covenants

Conservation covenants, protecting specific natural areas or binding development rights, are a good way to protect particular attributes of the land prior to sale.

The donor/client places a conservation covenant over certain portions or on specific uses of the land, and future owners must, by law, abide by the restrictions.

Covenants are also eligible for Ecological Gift certification. (0% capital gains)
Land trusts can hold the covenant and monitor and enforce them in perpetuity.

Subdivision

In the case of a large property with subdivision rights - with



both natural and developed areas, the area with ecological values could be separated and donated to a land trust, and the remainder sold. The charitable tax credits could help the owner cover incurred capital gains.

Sale/donation - Lease Back

In the case of working farms or ranches, owners may wish to sell or donate their property but retain the right to work the land for years to come. The land trust can help work out lease agreements that meet the farmer/rancher's needs, and transfers ownership.

Gifts of Residual Interest (life estate)

Some donors may wish to give their land to a charity but retain the right to use the property for a specified length of time. Sometimes this is until death, or it may be for a specified time limit.

Land Trusts in BC will:

- Provide information about gift options.
- Do ecological assessments.
- Receive gifts of land and provide charitable tax receipts.
- Monitor and steward the land forever.
- Provide recognition to donors and charities.
- Fundraise to meet sale prices in some cases.
